SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Do not breathe vapour/aerosol. Avoid contact with the substance. Eliminate all ignition sources if safe to do so. If possible, eliminate leakage. Provide adequate ventilation.
