### 5.2 Special hazards arising from the substance or mixture

Apply foam in abundant quantities since some of it gets destroyed by the product. Cool endangered containers with water spray and, if possible, remove from danger zone. Do not allow fire water to penetrate into surface or ground water.

### 6.3 Methods and material for containment and cleaning up
